The following is synopsis of the 2017 FAI Free Flight Team Selection Program posted on this site. Review it for specific details.

A. Entering the program

To accumulate time, fliers have formally enter the program by paying \$90 to the AMA/competitions department or \$25 if the flier was under the age of 25 when he/she entered the program (Junior fliers).

The entry fee is required from ALL the fliers who participate in the Finals.

B. Qualifying for the Finals

Option 1. accumulate 75 minutes in AMA sanctioned A-B-C contests.

Scoring is for the first 7 rounds, up to 3 minutes, excluding the flyoffs and extended maxes. If the max is reduced to 2 or 2:30 minutes and the flier maxed, their time is rounded up to 3-minutes. (So one can accumulate up to 21 minutes in a contest.)

Option 2: The 75 minute time accumulation can be waived if in addition to the entry fee the flier pays \$250 to the AMA prior to Dec 31st 2015 (\$90+\$250).

Option 3: Waiving the 75 minute time accumulation, the entry fee plus \$500 paid from Jan 1, 2016 (\$90+\$500).

C. Final's entry fee.

The cutoff time to accumulate time AND paying the Final's fees to the AMA is about a month before the Finals commence, per the official program.

Finals fees are \$250, \$50 for junior fliers. So,

- * Option 1: Fliers that time qualify pay ($\$90 + \$250 = \$340$).
- * Option 1J: Junior fliers who time-qualify pay ($25 + 50 = \$75$).
- * Option 2 bypassing time accumulation pay ($\$90 + \$250 + \$250 = \590).
- * Option 3 bypassing time accumulation pay ($\$90 + \$500 + \$250 = \840).

D. Finals will be held at Lost Hills over Oct 5-9 '16
